DESCRIPTION

We are all well aware of the potentially devastating effects of fires in the workplace in terms of lives lost, injuries, damage to property and the environment, and to business continuity. You may also be aware that it is believed most fires are preventable. The importance of fire safety in the workplace is underpinned by health and safety legislation that places a duty on employers to establish policies and procedures, and ensure their employees receive appropriate training.

This course is designed for employees who wish to develop their basic fire safety awareness in order to undertake more specific fire safety roles in the workplace to manage fire risk (e.g. as fire wardens/marshals/stewards etc.). Successful candidates will be awarded a nationally-recognised Level 2 Qualification.

DURATION

A minimum 6 contact hours in the classroom (one-day course).

CERTIFICATION

The participant will be awarded a Level 2 Qualification subject to successful completion of the test paper at the end of the session.

NUMBERS

A maximum of 16 students can be accommodated; all learners must be a minimum of 14 years of age.
